SLRCFA Board Meeting Minutes November 5, 2015

Meeting was called to order at 7 PM with the following members Jonathon Hendrickson, Bob Freukes, Ron Lawson, James Speelman, Shane Eisenbach, Kerry Eisenbach, Mark Stellern, Mike Stellern, Alan Main, and Doug Thompson in attendance. Also club members Dennis Chivetta, Drew Speelman, and Dave Ludwig were present.

- 1. Treasury report was read and accepted. Balance of \$2853.32
- 2. Warbird event made \$227.68 profit, after all expenses. SLRCFA will likely move the event up a couple weeks next year.


- 3. Discussed and approved 2016 budget proposal of \$15820.00
- 4. Ron Lawson announced his intentions to officially retire from treasurer at the end of this year.

If you are interested in being nominated please let a board member know before the December SLRCFA Board meeting.

- 5. Increase of SLRCFA's dues for 2016 passed unanimously. They will increase by \$10.
- 6. Constitution changes were discussed to change officers' positions to have term limits of 2 years. Motion was passed amongst board members and will need to be voted on by general club members at Christmas party.
- 7. Discussed storage containers and decided to wait and revisit in the future.
- 8. Discussed moving pilot stations. Motion passed to not allow flying out of the center of the field. All pilots must be in a flight station that is at correct end, depending on the wind direction.
- 9. Discussed winterizing field including finding a winter home for the mowers and taking down fan blades.

Battery Storage



Winter is on its way and you may not know it but your electric planes need some winterizing just like your gas or glow planes. You need to pay particular attention to your batteries. There are several different types of batteries and different storage methods/procedures for each.

LiPo or Li-ion

LiPo batteries should be stored at about 50% capacity. This is approximately 3.75-3.85 volts per cell. They should be stored in a cool dry location in a LiPo safe bag or fireproof container. To get the best possible capacity retention your LiPo should be stored at 32° F. Storage at this temperature has a capacity loss of 2% per year. Storage at 72° will result in a capacity reduction of 4% per year. A good way to achieve the 32°F storage would be to refrigerate them, but make sure that the batteries are placed in a plastic bag to protect against condensation before putting them in your LiPo safe bag.

LiPo's should always be stored in the method above even during the flying season. It is good practice to charge the battery to full the same day or the day before you are going to use it and then return it to 50% capacity for storage. LiPo's left fully charged will have their useful life drastically reduced.

LiFePO4

(A123 or Lithium Iron Phosphate)

LiFePO4 batteries store similar to LiPo's, but do NOT need the special LiPo storage bag for fire prevention. However the storage voltage is less at 3.2-3.35v per cell. They should also be stored at lower temperatures like the LiPo's.

NiMH (Nickel Metal Hydride)

Ni-MH batteries should be kept clean and dry during storage. They can be stored for many months in a charged or discharged state without any detrimental effects as long as they are not exposed to extreme temperatures for any long period of time. After storage the battery should be charged and/or cycled before use.

Proposed Constitutional Amendments

1) Purposed Amendment

Article 4, Section 3 currently reads:

The President, Vice President, Secretary, Treasurer and the Editor of the club's newsletter shall be permanently appointed by the Board of Directors. The Officers and Editor may resign at their discretion or be removed from office by an official act of the Board of Directors.

If amended Article 4, Section 3 will read:

The President, Vice President, Secretary, and Treasurer shall be elected by the Board of Directors for two year terms. The President and Secretary shall be elected for terms beginning in EVEN years, The Vice President and Treasurer shall be elected for terms beginning in ODD years. Officers may resign at their discretion or be removed from office by an official act of the board of directors. If needed, a special election will be held to fill any vacancies for the remainder of the term.

2) Purposed Amendment

Article 5, Section 1 currently reads:

The PRESIDENT shall preside at all meetings of the Board of Directors and the Membership, sign and issue checks, coordinate all committee activities, ensure that the role of safety officer is filled, negotiate official business and enforce the Constitution and By-Laws of this Association to the best of his or her ability.

If amended Article 5, Section 1 will read:

The PRESIDENT shall preside at all meetings of the Board of Directors and the Membership, sign and issue checks, coordinate all committee activities, ensure that the roles of safety officer and newsletter editor are filled, negotiate official business and enforce the Constitution and By-Laws of this Association to the best of his or her ability.

3) Purposed Amendment

Purposed change: insert Article 5 Section 7 If amended Article 5, Section 7 will read:

The Safety Officer shall promote and encourage a climate of safety awareness within the club. The Safety Officer provides a path of communication between the AMA and the club in matters related to safety. The Safety Officer annually completes a safety audit of club facilities, equipment, and grounds to ensure everything is in good working order and safe for normal use by members and the public. The Safety Officer establishes a club emergency action plan to handle serious accidents/incidents and annually reviews emergency procedures with

club members.

4) Purposed Amendment

Purposed change: insert Article 5 Section 8 If amended Article 5, Section 8 will read:

The Newsletter Editor shall publish SLRCFA's newsletter "Rotate," once a month. The Newsletter shall contain the Board Meeting Minutes, Membership dues structure, and Contact Information.
