

- 1. Treasury report was read and accepted with a balance of \$2658.90
- 2. Discussed renewal fee of \$15.99 for website domain name due before December 8th.
- 3. Board nominees were discussed for 2016. Tim Pastor and Dennis Chivetta accepted nominations.
- 4. Need to have general club vote at Christmas party about Constitution changes.
- 5. Motion passed to replace Ron Lawson as treasurer with Dennis Chivetta. We would all like to thank Ron Lawson for all his hard work in the 30+ years he has dedicated to helping the club become what it is today. Thanks Ron!! We will miss you and your Ron-dogs!!
- 6.Discussed Christmas party details. Decided that it would be best if everyone brought a dish to the party. We need to send out an email to general club and get a list of who is bringing what. It was also decided that we will have secret Santa raffle again this year with a \$15 minimum gift. Proposed Constitutional Amendments

1) Purposed Amendment

Article 4, Section 3 currently reads:

The President, Vice President, Secretary, Treasurer and the Editor of the club's newsletter shall be permanently appointed by the Board of Directors. The Officers and Editor may resign at their discretion or be removed from office by an official act of the Board of Directors.

If amended Article 4, Section 3 will read:

The President, Vice President, Secretary, and Treasurer shall be elected by the Board of Directors for two year terms. The President and Secretary shall be elected for terms beginning in EVEN years, The Vice President and Treasurer shall be elected for terms beginning in ODD years. Officers may resign at their discretion or be removed from office by an official act of the board of directors. If needed, a special election will be held to fill any vacancies for the remainder of the term.

2) Purposed Amendment

Article 5, Section 1 currently reads:

The PRESIDENT shall preside at all meetings of the Board of Directors and the Membership, sign and issue checks, coordinate all committee activities, ensure that the role of safety officer is filled, negotiate official business and enforce the Constitution and By-Laws of this Association to the best of his or her ability.

If amended Article 5, Section 1 will read:

The PRESIDENT shall preside at all meetings of the Board of Directors and the Membership, sign and issue checks, coordinate all committee activities, ensure that the roles of safety officer and newsletter editor are filled, negotiate official business and enforce the Constitution and By-Laws of this Association to the best of his or her ability.

3) Purposed Amendment

Purposed change: insert Article 5 Section 7 If amended Article 5, Section 7 will read:

The Safety Officer shall promote and encourage a climate of safety awareness within the club. The Safety Officer provides a path of communication between the AMA and the club in matters related to safety. The Safety Officer annually completes a safety audit of club facilities, equipment, and grounds to ensure everything is in good working order and safe for normal use by members and the public. The Safety Officer establishes a club emergency action plan to handle serious accidents/incidents and annually reviews emergency procedures with

club members.

4) Purposed Amendment

Purposed change: insert Article 5 Section 8 If amended Article 5, Section 8 will read:

The Newsletter Editor shall publish SLRCFA's newsletter "Rotate," once a month. The Newsletter shall contain the Board Meeting Minutes, Membership dues structure, and Contact Information.
